Note: It is the responsibility of all contractors, electricians, plumbers, and mechanics to obtain the necessary permits from the Building Department at Town Hall before ANY work has begun. Work must begin one year of the issuance of any permit.

Gas fitters must have a valid license from the State of New Hampshire to obtain a permit. Permits are not transferable.

It is the responsibility of the contractor to obtain all inspections required. A rough-in inspection is required before any work is covered, and a final inspection is required when all work is complete. A forty-eight (48) hr notice is required for any inspection.

This signed application constitutes consent on the applicant's part to allow for all inspections at the property location listed.

No permit will be issued until all of the above information is furnished, and all the above conditions met.

INSPECTIONS REQUIRED: (48 hours' notice required)

- 1. When rough-in is complete and visible (Rough)
- 2. When job is complete, but before occupancy (Final)

The Building Department approval would certify that the applicant could proceed with certain mechanical work in accordance with the specifications submitted. Any deviation from the specifications submitted will require an amendment to this permit or additional permits.
