RSA 675:4 PETITION TO AMEND ZONING ORDINANCE

Pursuant to RSA 675:4, the undersigned voters of the Town of Conway, being more than twenty-five (25) in number, hereby submit to the Board of Selectmen the following petition to amend the Town of Conway Zoning Ordinance, such Article to be included on the Warrant for the 2025 Annual Town Meeting:

To see if the Town will vote, anticipating the potential dissolution of the Kearsarge Lighting Precinct, to amend the Zoning Ordinance of the Town of Conway as follows:

1. Add Section 190-29.2, entitled "Kearsarge Lighting Precinct Area Overlay (KLPAO) District" as follows:

The KLPAO District is primarily designed to maintain certain aspects of zoning within the area that is or was the Kearsarge Lighting Precinct, in anticipation of and to facilitate a dissolution of the Kearsarge Lighting Precinct.

- A. District boundaries and map.
 - (1) District boundaries. The KLPAO District shall be the entirety of the Kearsarge Lighting Precinct as it existed within the boundaries of the Town of Conway.
 - (2) District map. The KLPAO District Map is included as an attachment to this chapter [which shall be the map entitled "Property Map of the Kearsarge Lighting Precinct located in the Towns of Conway & Bartlett, New Hampshire, prepared by H.E. Bergeron Engineers, Inc. and dated July 26, 1990 (revisions through April 17, 2012)].
- B. Restrictions.
 - (1) Notwithstanding and in addition to any other provision in this Zoning Ordinance, all lots within the KLPAO District shall meet the following minimum requirements for any use or any structure:
 - (a) 2 acres;
 - (b) 250 feet of frontage;
 - (c) 80 foot front setback; and
 - (d) 25 feet rear setback,

Except that the provisions of § 190-30 with respect to preexisting nonconforming uses, structures, or lots shall apply to these restrictions.

2. Amend Section 190 Attachment 2 (Permitted Use Table) to add a line for the Kearsarge Lighting Precinct Area Overlay (KLPAO) District" with "u" noted for all uses.
