REVIEW AND ACCEPTANCE OF MINUTES

Mr. Hartmann made a motion, seconded by Mr. Fougere, to approve the Minutes of March 23, 2017 as written. Motion unanimously carried.

PUBLIC HEARING – TREE REMOVAL ON A SCENIC ROAD – RSA 231:158

Jon Lamphere of Lewis Tree Service for Eversource appeared before the Board. This is a public hearing for the removal of trees along a designated scenic road, Davis Hill Road, to facilitate utility services. Ray Shakir joined the Board at this time and became a voting member. Mr. Steiner became a non-voting member at this time.

Mr. Drinkhall opened the public hearing at 7:02 pm. Mr. Drinkhall asked for Board comment; Mr. Hartmann asked if the abutter's have been properly notified. Mr. Irving stated this did not require individual notification; there were two notices in the newspaper. Mr. Irving stated the utility company contacts the property owners. Mr. Drinkhall asked for public comment; there was none. Mr. Drinkhall closed the public hearing at 7:04 pm. **Mr. Porter made a motion, seconded by Mr. Fougere, to accept the proposal. Motion unanimously carried.**


OTHER BUSINESS
