CLOUD PERMIT DEMONSTRATION

Peter Rotenberg from Cloud Permit appeared before the Board via Zoom.

He gave the Board a history of the company and discussed many of the features of their software that will increase efficiency in the Building, Planning and Zoning Departments.

Mr. Thibodeau asked Mr. Rotenberg's opinion on the amount of storage needed for the iPads to accompany this program.

Mr. Rotenberg explained that since this was cloud based, they only needed 64 gb, however, more storage is always better for the longevity of the devices.

It was stated that if they move forward with the software, they could complete the first module set up for the Building Department in 4-6 weeks with an approximate full completion timeline for all departments of 8-11 weeks.

The Board thanked Mr. Rotenberg.
